Privacy Policy

Your Privacy is Important to Us

We don't ask you for personal information unless we truly need it. We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights. We don't store personal information unless required for the on-going operation of one of our services. In our products, we aim to make it as simple as possible for you to control what's visible to the public, seen by search engines, kept private, and deleted. The Sun Coast Osteopathic Foundation (S.O.F.) operates the website www.suncoasoseopathic.org. It is S.O.F. policy to respect your privacy regarding any information we may collect while operating our website.

Website Visitors

S.O.F. sometimes collects non-personally-identifying information. S.O.F. purpose in collecting non-personally identifying information is to better understand how S.O.F. visitors use its website. From time to time, S.O.F. may release non-personally identifying information in the aggregate, such as trends or usage reports. S.O.F. may collect potentially personally identifying information like Internet Protocol (IP) addresses. S.O.F. does not use such information to identify its visitors, however, and does not disclose such information, other than under the same circumstances that it uses and discloses personally-identifying information, as described below.

Gathering of Personally Identifying Information

Certain visitors to the S.O.F. website choose to interact with S.O.F. in ways that require S.O.F. to gather personally-identifying information. The amount and type of information that S.O.F. gathers depends on the nature of the interaction. Those who engage in transactions with S.O.F. – may be asked to provide additional information, including as necessary the personal or financial information required to process those transactions. In each case, S.O.F. collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with S.O.F.. S.O.F. does not disclose personally identifying information other than as described below. And visitors can always refuse to supply personally identifying information.

Aggregated Statistics

S.O.F. may collect statistics about the behavior of visitors to its websites. For instance, S.O.F. may monitor website or social communities. S.O.F. may display this information publicly or provide it to others. However, S.O.F. does not disclose personally identifying information other than as described below.

Protection of Certain Personally-Identifying Information

S.O.F. discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that: Need to know that information in order to process it on S.O.F. behalf or to provide services available at the S.O.F. websites and; That have agreed not to disclose it to others. By using the S.O.F. website, you consent to the transfer of such information to them. S.O.F. will not rent or sell potentially personally identifying and personally identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, S.O.F. discloses potentially personally-identifying and personally-identifying information only when required to do so by law, or when S.O.F. believes in good faith that disclosure is reasonably necessary to protect the property or rights of S.O.F., third parties or the public at large. If you are a registered user of an S.O.F. website and have supplied your email address, S.O.F. may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with S.O.F. and our products. We primarily use our various product blogs to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. All though S.O.F. takes reasonably necessary safeguards to against the unauthorized access, use, alteration, or destruction of potentially personally identifying information, S.O.F. is not liable for unauthorized use.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. S.O.F. may use cookies to help S.O.F. identify and track visitors, their usage of S.O.F. website, and their website access preferences. S.O.F. visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using the S.O.F. website, with the drawback that certain features of the S.O.F. website may not function properly without the aid of cookies.

Ads

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by S.O.F. and does not cover the use of cookies by any advertisers.
